NOTICE IS HEREBY GIVEN THAT A GENERAL ELECTION will be held in all precincts of all Cities and Townships within the County of Berrien, State of Michigan on **TUESDAY, NOVEMBER 6, 2018**, for the purpose of electing Offices to be voted on are: Governor & Lieutenant Governor; Secretary of State; Attorney General; U.S. Senator; Representative for U.S. Congress; State Senator; State Representatives; State Board of Education; University of Michigan Regents; Michigan State University Trustees; Wayne State University Governors; Justice of the Supreme Court; 3rd District Court of Appeals; 2nd Circuit Court Judge; 5th District Court Judge; Probate Court Judge; County Offices; and Local Offices.

Local proposals as indicated under individual city and township heading below shall also be voted on. For full text of local proposals, contact the local clerk.

Persons with special needs, as defined in the American with Disabilities Act, shall be supplied with Braille or audio instruction upon request. To comply with the Help America Vote Act (HAVA), voting instructions will be available on CD and in Braille. All polling locations are accessible for voters with disabilities.
